### **Another Round of Bills**

**T**hank you for accepting me as your new VP of Legislation for OCAHU. I am very excited to take on my role and everything that comes with it. If you have any questions about State or National legislation, or if you would like to know more about what OCAHU is doing

for you on a legislative level, I am here for you! Feel free to email me any time at <u>casey@beaconpath.com</u>. I encourage you to email me and stay involved; it's important to stay abreast of the legislation running through our state and national governments.

As we begin the new OCAHU year, I'd like to bring forth a few bills that are at the top of the CAHU priority list. We'll start with SB 161, which is a bill most of you should know about. SB 161 (Hernandez) is a senate bill that deals with stop-loss insurance for small employers and sets specific parameters on what the minimum levels of insurance can be. CAHU was originally opposed to this bill, but as of June 28<sup>th</sup> 2013, CAHU has amended its position and now takes *no position* on SB 161. CAHU was part of a coalition that fought against SB 161; a compromise was reached after working with state legislators. Both the coalition parties and our state legislators are unhappy with the compromise, meaning this must be as good as it will get. CAHU and the other parties in the coalition withdrew their opposition to the state bill after its new limits on minimum coverage were amended.

Although CAHU takes no position on SB 161, CAHU Vice President of Legislation, Dan Webb, reminds us that this doesn't mean individual brokers can't continue the fight against SB 161. Dave Fear of Sheplar & Fear General Agency has created his own coalition to continue the fight against SB 161. Along with SB 161, there are a few other bills to keep our eyes on:

- AB 18 (Pan) MLR Mandate on Pediatric Dental Plans CAHU Opposes in Assembly Appropriations
- AB 889 (Fraser) Step-Therapy Changes to Rx CAHU Opposes Moved to Suspense File 8/12/2013
- AB 912 (Quirk-Silva) Fertility Preservation CAHU Opposes Moved to Suspense File 8/12/2013

 SB 639 (Hernandez) – HBEX Competition Elimination – CAHU Opposes – In Assembly Appropriations

There are twenty-one total bills listed on the CAHU Priority Bill List. You can also find information on all bills running through California at <a href="leginfo.legislature.ca.gov">leginfo.legislature.ca.gov</a>. Both of these sites are great resources to help you stay informed on legislative issues.

Aside from the websites listed above, I encourage to you come to our monthly OCAHU meetings. I will give updates on the actions CAHU is taking to advocate on our behalves, and will keep you posted on the bills that are most important to us. In the meantime, make sure you are registered with CAHU's VoterVoice so you can be a part of the fight for good, helpful legislation in favor of brokers, insurers and our clients.
